
interest to muzzleload shoot of about \$10.00 in value. Here were some ideas: • Cast round balls • Shooting and/or cleaning patches • Ball starters

Bang!

Bang! Without the NRA, you would probably never hear that sound from a firearm. When the National Rifle Association was founded in 1871 by General George Wingate and Col. William C. Church, their main goal



was to promote and encourage rifle shooting on a scientific basis. Over the years that main goal has changed to preserveing our second amendment rights, while promoting the safe use of firearms.

With all of the NRA's programs, you would think that at least one of them would be dedicated to safety, right? Well, you're in luck because not only is one of their programs dedicated to safety, but all of them teach safety. One of their most popular courses for children, called "Eddie Eagle" has reached over twenty one million children in America. Eddie Eagle is not a program that promotes or demotes the use of firearms, but primarily focuses on what a child should do if he or she ever found a gun.

Besides Eddie Eagle, other programs such as the Basic Rifle course, which I have been lucky enough to participate in, have specific chapters and lessons on how to operate and take care of that specific firearm safely. They supply shooting clubs with tools they need such as handbooks, posters, and videos to teach about safety. The NRA has done a phenomenal job promoting the safe use of firearms.

Another NRA Youth program is Y.E.S. also known as the Youth Education Summit. The Youth Education Summit is entirely focused on education. In the YES program, high school students that have applied for the program all around the country are chosen to go to Washington DC. where they tour the capital, visit historical sights, and meet national leaders, as well as participating in debates. The students are there to learn of course, about the importance of becoming an active United States citizen, but there is another catch. They are all competing for a college scholarship. At the end of the program a select few of the students win college scholarships for their performance during the trip. Personally, I think getting accepted to go on the trip would be more than enough, but winning a college scholarship would make it that much more special. \square

Legislative Committe by Ned Hogan

Recently 2 anti-gun activists from Chester, PA met with several PA State Legislators to push for a requirement that every bullet sold in the state be encoded "to provide law enforcement with more investigative tools." I'm not sure what other PA State Legislators attended, but the spokesman for Sen. Pileggi, whose 9th Senatorial District includes most of our PA Club members, spoke highly of this measure after the meeting. In addition to being Senator for most of us, Dominic Pileggi is the Senate Majority Leader and can use his position to advance this idea in Harrisburg if he chooses. Senator Pillegi was the Mayor of Chester, PA before his election as State Senator; the crime problems of that city likely shape his views on the subject of guns, ammunition, and their criminal misuse by gang members.

Harrisburg, PA 17120-3009; email dpileggi@pasen.gov; 888-984-3478 to express their opposition to this proposal, which if passed would result in great additional expense to ammunition manufacturers, and result in companies either going out of business, or passing on these costs to law abiding citizens who are shooters and hunters.

Looking at the technical problems, the Remington Company alone manufactures 25 billion rounds/year of .22LR ammunition; virtually all of which is used lawfully for training and target shooting. Marking each bullet uniquely would require at least an 11 digit code on each .22 bullet to uniquely mark one years' output. Allowing for 10 years of production without a repeat, plus some sort of marking to show the manufacturer of any recovered bullet, requires 13 or 14 identifying digits (minimum) to uniquely identify a crime scene bullet. If the bullet is deformed or scratched by hitting something, as most are, illegibility of a single digit would render the rest of the markings useless for tracing. Engraving a bullet with 11 to 14 digits would also unbalance the bullet to an extent that it cannot be gyrostabilized and would thus affect accuracy.

If the technical difficulties could be solved, the proposed law will still not solve any "problem" it is being touted to correct. Remember that the Gun Control Act of 1968 was authored in 1963 and pushed for 5 years by CT's late Senator Dodd, and was aimed specifically at choking off foreign competition from cheap surplus imported arms and ammunition. Senator Dodd's constituency included some of the largest gun and ammunition companies in the United States. The law required law abiding citizens to complete almost as much information to purchase a box of .22 ammo as it did to purchase a firearm; the result was 20,000 Domestic ammunition dealers went out of business because the profit from sales did not pay for the time required to complete and process the additional paperwork. Finally, the Government regulators themselves (BATFE) admitted that ammo sales records had never helped trace ammo or advance a criminal investigation in their 18 years of operation and recommended that Congress remove the record keeping requirement from the law. This was done in 1986.

Ammo registration having failed on a National Level, a State Law would fare even worse. A State law would not deter a criminal from purchasing ammunition in another State and using it to commit a crime in Pennsylvania.
