A Member, a Mission, a Flag

The Burton Hall Flag Flies Over Kuwait

Club member Drew Clauhs, a sergeant in the Army National Guard, took our prized "Burton Hall" American flag on an interesting trip last year.

Thanks to Drew's good work, our Club's flag flew over the largest military seaport in the world from about 0100 hours to 2300 hours on 4th July 2013. That period of display covered most of the clock that hot (104 °F), windy day. It's a distinct honor for us, especially to be part of such a remarkable testament to America's reach, purpose and commitment.

The port in question is the Seaport of Debarkation and Embarkation, near the city of Al Shuiba, Kuwait. SPODE Kuwait handled all US and allied material in and out of

Kuwait and for much of the Iraq theater of operations. If it got to the fight in Iraq, it came through the SPODE.

Drew's unit, 104th Cavalry, Pennsylvania Army National Guard - the "Black Jack Troop" - had security and surveillance duty for the port as well as the southern half of Kuwait, as Security Force, South. He was in the sandbox for nine months on his tour.

His story, and that of our flag, has been featured on several media outlets. We are grateful to him for his efforts, not only in serving the nation but also in arranging a distinctive honor for the club's national flag.

We're Open for New Members

With the annual membership renewal effort behind us (Amy Hutchins and Chris Carapellucci lived to fight another day), we can now re-open our rolls for new members.

Club Members Rally for 2nd Amendment

The people who want to take our guns away or otherwise limit the right to keep and bear arms enshrined in the Constitution will never stop trying. At the federal, state and local level, they are always looking for ways to pry our guns out of our homes and hands. Sometimes their tactics are overt and direct; sometimes they are subtle and disguised, often under the label of "common-sense gun laws" or "sensible" legislation.

The truth is, the only thing that stands between them and a catastrophic diminution of our ability to defend ourselves

and our other freedoms is the concerted commitment of free citizens like you.

Several of your fellow club members demonstrated that commitment on a bitterly cold January day, when they rallied to support one of the elected officials who sees things our way.

State Representative **Steve Barrar** (R - 160th District) has come under pressure from a group called Delco United for Sensible (there's that word, again) Gun Policy. The group's complaint is that Steve has not chosen to co-sponsor (or support) House Bill 1010, which would prohibit the sale of long guns among private individuals in the Commonwealth without an NCIS background check.



Steve's position is much like ours: that there are plenty of gun laws on the books already and that the Federal government has no brief in getting in the middle of a private transaction between free citizens, especially one enabled under current state law.

We couldn't agree more and the turnout among club members and other interested parties in support of Steve at his offices on Route 202 was remarkable. So was the reaction of the drive-by crowd, which was obviously and audibly on the side of the U.S. Constitution.

A Trip to the NRA Convention

Getting Ready for Indianapolis with a Look-Back at Houston. Last year Club member Mark Garfinkel attended the NRA annual convention in Houston. Here are his thoughts and observations:

Houston was my third Annual Meeting in four years and to date, the best and largest by far. Thank you, Houston. After three such trips, I am just now learning the lay of the land - NRA land, that is. With seven days of meetings and events scheduled, I would like this article to be a "How To Guide" for all of you planning on attending future NRA conventions, and a report of what I learned from the Houston convention, last year.

With exhibit space exceeding 639,000 sq. ft., and another 600,000 sq. ft. of meeting rooms, classrooms, ballrooms, theaters, 240 NRA staff, 500 NRA volunteers, over 450 exhibitors and their staff and, most importantly, the friendliest 86,228 attendees (NRA official count) from all over the country, you can easily see that all this can be overwhelming at first.

I began by setting several goals for the meeting. My first was to learn more about our organization. I attended the entire Membership Meeting on Saturday and the Board of Directors meeting on Monday. I would like to thank John Sigler for answering all my endless questions. On Monday, at the Board of Directors Meeting, it was announced that the Harrisburg, PA Outdoor Show (formerly the Eastern Sports and Outdoor Show) is going to be sponsored by the NRA.

The next goal was to organize my time around the different seminars being offered on Thursday, Friday and Saturday. My passion is education and training, and my choices were directed by those seminars that fit the bill.

The next goal and biggest challenge was navigating the exhibit hall. In advance, using nraam.org I mapped out a plan of attack targeting exhibitors with whom I wanted to spend time. The Excel spreadsheet that I developed kept us on track, and I would recommend you doing the same.

The last and most important goal was to have fun, which was easily available to anyone who did a bit of planning.

Yes, Houston, we have a problem, but our politicians did not count on you, members of the NRA and defenders of our Constitution, standing up for your 2nd Amendment and your freedoms. So, set a goal for April 25th-27th, 2014 and let's see if we can have an attendance of over 100,000 in Indianapolis.

Black Powder

The Black Powder Committee will be active at SCCS&FA again this year.

The following dates (also published in Muzzle Blasts, the NMLRA magazine) will be match or event dates for muzzleloader fans at the Club:

- Sunday March 30, 2014 – currently reserved for the Delaware 1st Regiment Training
- Sunday June 1 2014 – Target Match
- Sunday August 31 2014 – Target Match
- Sunday October 26 2014 – Target Match

Target matches are open to any muzzle-loading rifle, Inline rifles welcome. Open sights only, peep-sights acceptable.

Matches begin at noon until 4pm. Targets at 25 and 50 yards. Three prizes awarded for each target.

We plan to offer a mid-September muzzle-loading sight-in day, open to all members. Open sights at 50 yards, scopes at 75 yards. There will be an informal target match with small prizes. Fee: \$5.00.

We are also considering sponsoring a Junior rifle-kit building course. The idea is to build a kit rifle with Mom, Dad or other interested adult, with the course running over several weeks. Kits would cost in the \$250 range.

Basic Muzzleloading class - NRA/NMLRA. According to NMLRA field rep and training counselor, Richard Neikamp, The NRA and NMLRA have entered into an agreement to update their Basic Muzzleloading training courses. The course will now fold rifle, pistol and muzzleloading shotgun programs into one class. Instructors will receive certification from both associations simultaneously.
